 - To be fully implemented in 2025
 - Research Material Management/Inventory Management
 - Currently under evaluation

- **Transaction Risk Analysis and Audit Software**
 - Oversight
 - Implemented in 2019
- **Customer Service Solution**
 - Customer Service Portal/Help Desk
 - Implemented in 2014



Autonomous AP

- **Procure to Pay Software Benefits**
 - Initial Jaggaer Implementation
 - Eliminated paper based processes
 - Easy to use interface
 - Risk and rule based workflow allows for low risk invoices to auto approve
 - Automated
 - Workflow approvals
 - 3-Way match
 - 2-Way match
 - Electronic Invoices (cXML, CSV or supplier portal initiated invoices)
 - Fully integrated into ERP



Autonomous AP

- **Procure to Pay Software Benefits**
 - Initial Jaggaer Implementation
 - Improved tracking
 - Improved turnaround time
 - Reduced prompt payment
 - Increased early payment discount taken
 - Easier to train users
 - Centralized processes
 - Shared services
 - Analytics to track metrics



Autonomous AP

- **Procure to Pay Software Benefits**
 - Invoice Ingestion
 - Digital Mail Room
 - Helped to reduce volume of manual entry
 - Ingested within 48 hours of receipt
 - Allowed staff to focus more on audit, compliance feedback and approvals
 - Negatives – invoice entry of data was inconsistent and required duplicative manual review of DMR work.

- Invoice Ingestion

- AppZen

- Solution provides high live of AI and RPA along with the OCR
 - Predictive coding for non-po based invoices
 - Allows for centralization of non-po based invoices
 - Instant ingestion of invoice into Jaggaer that has high level of confidence
 - The AP team trains the ai while they rectify invoices where the system lacks confidence
 - AI based email inbox management
 - One email address for vendors
 - Further improve prompt payment, discounts taken and turnaround times

 - Supplier Onboarding and Maintenance
 - Supplier Manager
 - Reduces Risk of Fraud (ACH and tax id)
 - Supplier managed profile
 - Reduces data entry and allows for focus on compliance
 - Visual compliance check
 - Automated IRS check
 - Improves accuracy

 - Supplier Onboarding and Maintenance
 - Supplier Manager
 - Integration into ERP vendor master
 - Dual Factor Authentication
 - Improves turnaround times/efficiency
 - Visibility to PO, invoice status, payment information
 - Improves vendor communication and satisfaction
 - State hold integration
 - State HUB integration

 - Reduces fraud liability and risk of fraud
 - Decreases costs
 - Check printing
 - Envelope printing
 - Postage
 - Inserter
 - Staff time
 - Banking fees
 - Increases revenue via rebate

 - Payment and settlement dates
 - Image of distributed and settled check
 - Future release - image of payment remittances
 - Supplier can view payment information on invoices in supplier portal

 - Expectations
 - Improve user satisfaction
 - In product assistance for first time or infrequent users
 - » User guided walkthroughs
 - » Virtual Assistant
 - » Other customized resources
 - Use of AI capabilities being developed
 - » Commodity code recommendations
 - » Eventually will be able to select commodity code

 - Business rules imbedded in the workflow helps to reduce risk and drive compliance
 - Automated
 - Workflow approvals
 - Expense type assignment
 - Itemization
 - Receipt capture

 - Lower costs
 - Unlimited expense reports
 - Improved user interface
 - More intuitive and efficient
 - Approve by email
 - Delegate can submit on behalf of traveler
 - Mobile app same look and feel as desktop version

- Chrome River

- Expect all benefits received from Concur with the below improvements
 - More flexible and configurable
 - Workflow routing is line item based
 - » Allows for partial approval
 - » Presents approver with just those lines in the expense report the approver is responsible for
 - » Risk based approval
 - Facilitates a one card solution
 - Improved visibility
 - Drillable Dashboards



Autonomous AP

- **Transaction Risk Analysis and Audit Software Benefits**
 - Oversight
 - Analyzes every disbursement transaction for risk, compliance and duplicates
 - Card
 - Out of pocket
 - AP Invoices
 - Validates receipt attached and using OCR that it matches card transaction
 - Allows for expense report auto approvals in Concur/Chrome River
 - The analysis will produce findings for auditors to assign and review



Autonomous AP

- **Transaction Risk Analysis and Audit Software Benefits**
 - Oversight
 - Template responses by finding type
 - Tracks communication to expense owner
 - Evaluates historical findings by expense owner
 - Improves feedback and compliance
 - Improves auditor consistency
 - Allows auditors to focus on higher risk and out of compliance items
 - The audit process is much more efficient
 - Data analytics - items out of compliance, expense owner out of compliance and auditor work volume



Autonomous AP

- **Customer Service Solution**

- Customer Service Portal/HelpDesk

- Improves response times
 - Template responses
 - Allows for more accurate and consistent communication by agents
 - Tracking of tickets
 - Volume of tickets worked by agent
 - Workload balance
 - Managers can monitor responses by agents
 - Single point of contact email/phone for our customer base
